Biography

Jeff Hunt is General Counsel for the Intelligence, Surveillance, and Reconnaissance Systems (ISRS) mission area in Raytheon Space and Airborne Systems. In this role, Jeff provides a wide range of legal advice that helps shape Raytheon business activities in the United States and around the world.

Prior to joining Raytheon, Hunt served as an aviator and later as a Judge Advocate in the United States Navy. While in his last Navy assignment, Hunt served as Executive Officer with the Navy's prosecution command in Washington, DC. In this role, Hunt helped guide the investigation and prosecution of complex criminal cases involving Navy and Marine Corps personnel. Before that assignment, Hunt served as Legal Advisor for the U.S. Military Delegation to the North Atlantic Treaty Organization (NATO) in Brussels, Belgium. In this Joint Staff assignment, Hunt provided legal advice to senior U.S. government representatives including the U.S. Ambassador to NATO, U.S. Military Representative to NATO's Military Committee and the Secretary of Defense's Representative Europe. He was also involved in development and implementation of NATO's Anti-Human Trafficking efforts.

Earlier in his career as a uniformed lawyer, Hunt served on the faculty at the U.S. Naval Academy, Staff Judge Advocate for a carrier battle group, Special Assistant U.S. Attorney, and as a supervising prosecutor and defense counsel. Hunt began his legal career after he was selected for the Navy's Law Education Program that transitioned him from carrier pilot to the Navy's Judge Advocate General's (JAG) Corps.

Hunt's Navy career began in 1986 with Aviation Officer Candidate School in Pensacola, Florida. He earned his Navy wings in 1988. In the fleet, Hunt flew E-2C Hawkeye aircraft with VAW-114 aboard the USS Carl Vinson (CVN-70).

Before joining the Navy, Hunt served as a California State Assembly Fellow (1985-1986) working on the staff of the Water, Parks and Wildlife Committee.

Hunt is a member of the American Bar Association and the Association of Corporate Counsel.

Hunt earned his undergraduate degree from the California Polytechnic State University in San Luis Obispo. His law degree is from the Vanderbilt University School of Law in Nashville, Tennessee.
